NOTICE TO BIDDERS

Contracts shall be awarded by the McCracken County Fiscal Court to the lowest and/or best bid by a qualified bidder. In determining best bid, in addition to price, the McCracken County Fiscal Court may consider:

1. Does the proposal meet or exceed established standards set in bid package.
2. The ability, capacity and skill of the bidder to perform the contract or provide the service required;
3. Number of days required for lighting installation;
4. The quality of performance of previous contracts or services;

BIDDER INFORMATION

1. The McCracken County Fiscal Court reserves the right to accept or reject any or all bids or part thereof, to accept one or more items of a bid without obligation as to other items, and to waive any informalities or irregularities.
2. The bidder shall obtain a McCracken County Business License.
3. Bidder responsible for all field measurements and layout.
4. The bidder shall submit product description sheets and manufacturer installation requirements on all products used in the installation of the lighting.
5. A lighting plan with a minimum average maintained horizontal foot-candles of 300 lux within primary playing area shall be submitted.
6. A lighting plan with a minimum average maintained vertical foot-candles of 200 lux within primary playing area shall be submitted.
7. LED lighting shall be source of light for outdoor courts.
8. Pre-bid conference: None
9. The McCracken County Fiscal Court is exempt from Kentucky State Sales Tax.
10. Bid to remain good for sixty (60) days after the Bid Due Date.
11. All bids must contain this form bearing a signature of an authorized officer or representative of the Bidder in order to be considered valid.
