Vehicles furnished in general compliance with this specification shall be a new 2023 Chevrolet Tahoe (or equal), with base model trim package LS or LT. The vehicle purchased under this price contract shall be factory equipped with safety equipment and in conformance with the federal motor vehicle safety standards and vehicle emissions regulations applicable at time of delivery for its model year. Successful bidder shall minimally supply one (1) operator's manual upon delivery and two (2) key fobs. Vehicles shall be equipped with manufacturer's standard equipment as listed in the manufacturer's literature, including such equipment that comes standard, plus any accessories specified herein which may be optional. If vehicle cannot be in stock and ready for delivery by September 30, 2023 and exception should be noted on the bid form.
