A. It is ordered that JP Kelly is appointed to the Paducah McCracken County Riverport Board for a term ending \_\_\_\_\_\_.

## VI. COURT ORDERS

- A. It is ordered to pay the invoice dated March 30, 2024, to Paducah Sun for the Sports Complex Project, in the amount of \$274.04. This is pursuant to the Interlocal Cooperation Agreement dated September 7, 2022, between City of Paducah, Kentucky, the County of McCracken County, Kentucky, and the Sports Tourism Commission. As per the Interlocal Agreement, the City of Paducah pays half of the invoice to McCracken County. Further, the Treasurer is authorized to transfer \$137.02 from the General Fund to the Sports Complex Project Fund.
- B. It is ordered to pay the invoices dated February 25, 2024, and March 25, 2024, to PFGW for the Sports Complex Project, in the amount of \$92,948.25. This is pursuant to the Interlocal Cooperation Agreement dated September 7, 2022, between City of Paducah, Kentucky, the County of McCracken County, Kentucky, and the Sports Tourism Commission. As per the Interlocal Agreement, the City of Paducah pays half of the invoice to McCracken County. Further, the Treasurer is authorized to transfer \$46,474.13 from the General Fund to the Sports Complex Project Fund.
- C. It is ordered that \$528,400.00 from the Transient Room Tax Escrow fund be transferred to the City of Paducah for bond payment on the Convention Center and Carson Center Series 2020B GOB.
- D. It is ordered that the Fiscal Court sponsor the Juneteenth event at The Carson Center in the amount of \$2,000.00 and the Treasurer is authorized to pay invoices related to the same.
- E. It is ordered to receive and record the FY 2023 McCracken County Fiscal Court Audit.
- F. It is ordered to engage Patrick and Associates, LLC, to perform audit services for McCracken County Fiscal Court for a period beginning July 1, 2023, and ending June 30, 2024.
- G. It is ordered to pay Bluegrass Integrated Communications \$17,077.71 for prepostage on mailing the voter redistricting postcards.
