CALL TO ORDER ROLL CALL PRAYER PLEDGE OF ALLEGIANCE

I. <u>CONSENT AGENDA</u>

It is ordered to approve the Consent Agenda for June 24, 2024, McCracken County Fiscal Court.

II. <u>BUDGET TRANSFERS</u>

It is ordered that the necessary cash transfers, in the amount of \$450,000.00 be made in order to pay County bills and payroll approved June 24, 2024.

III. ACCOUNTS PAYABLE

It is ordered to approve the Voucher Claims Register from June 10, 2024, to June 24, 2024, to show County bills in the amount of \$483,206.77 were paid.

IV. BOARD APPOINTMENT

- A. It is ordered that Will Cox is appointed to the JSA Board for a term July 1, 2024 to June 30, 2028.
- B. It is ordered that Alexandra Sherwood is reappointed to the Paducah-McCracken Convention Center Board for a term July 1, 2024 to June 30, 2027.

- C. It is ordered that Darryl Pea is reappointed to the Paducah-McCracken Convention Center Board for a term July 1, 2024 to June 30, 2027.
- D. It is ordered that Terri Lundberg is reappointed to the Workforce Development Board for a term 7/1/24 to 6/30/26.

- K. It is hereby ordered that Sprinturf, LLC be awarded Bid Package 1A/Field Turf for materials and installation of artificial sports field turf at the Paducah Sports Park in the amount of \$6,321,087.00. Sprinturf, LLC was selected on the basis of being the best evaluated bid. It is further ordered that the Judge Executive be authorized to enter into a contract and sign all necessary documents for same; and the Treasurer be authorized to pay invoices.
- L. It is hereby ordered that Musco Sports Lighting, LLC be awarded Bid Package 1B/Sports Field Lighting for the materials and installation of sports lighting at the Paducah Sports Park in the amount of \$2,264,475.00. Musco Sports Lighting, LLC is selected on the basis of being the lowest and most responsive bidder. It is further ordered that the Judge Executive be authorized to enter into a contract and sign all necessary documents for same; and the Treasurer be authorized to pay invoices.
- M. It is hereby ordered that A&K Construction of Paducah be awarded Bid Packages 1C/General Site Construction and 2A/Buildings for construction of the Paducah Sports Park in the amount of \$47,771,839.00. A&K Construction is selected on the basis of being the lowest and most responsive bidder. It is further ordered that the Judge Executive be authorized to enter into a contract and sign all necessary documents for same; and the Treasurer be authorized to pay invoices.
- N. It is hereby ordered that Stafford-Smith, Inc. be awarded Bid Package 2B/Food Service Equipment for materials and installation of food service equipment to be used at the Paducah Sports Park in the amount of \$608,833.00. Stafford-Smith, Inc. was selected on the basis of being the sole responsive bidder. It is further ordered that the Judge Executive be authorized to enter into a contract and sign all necessary documents for same; and the Treasurer be authorized to pay invoices.

VI. ORDINANCE

A. 2nd Reading:

Commonwealth of Kentucky McCracken County Fiscal Court Ordinance No. 2024-05

An Ordinance repealing, in its entirety, McCracken County Ordinance No. 2021-09, setting forth the previous form of the McCracken County Administrative Code, and enacting a replacement Administrative Code

containing all amendments enacted subsequent to the initial passage of McCracken County Ordinance No. 2021-09.

Summary: The present action is mandated by KRS 67.710 and KRS 68.005 and operates to repeal in its entirety the current McCracken County Administrative Code as previously enacted by Ordinance No. 2021-09 and containing the numerous amendments enacted subsequent to its initial passage. The present action allows the full incorporation of all such subsequent amendments into a single self-contained code for ease of administration and more effective and efficient notice of and compliance with its provisions.

Certification: It is hereby certified by the McCracken County Fiscal Court that the present summary represents an accurate official statement of the main points of and contents of Ordinance No. 2024-05.

Public Inspection: Ordinance No. 2024-05 shall be available for public inspection in its whole and complete form in the McCracken County Judge Executive's Office during ordinary business hours.

B. 2nd Reading:

Commonwealth of Kentucky McCracken County Fiscal Court Ordinance No. 2024-06

An ordinance establishing and imposing a fee on all occupied real estate parcels located within the territorial limits of McCracken County outside the limits of the City of Paducah to facilitate funding for the provision of Joint 911 Services as more fully set forth in the Interlocal Agreement between the City of Paducah and McCracken County.

Summary: The actions effectuated in the present Ordinance operate to establish and impose an annual fee on all occupied real estate parcels located within McCracken County to fund the provision of 911 communication systems and services. The Ordinance provides a fee scale that bears a reasonable relationship to the benefit received, and which considers the use and size of the property. Further, the Ordinance provides the methods for collection of the fee and the consequences of its nonpayment. Additionally, the Ordinance establishes a county appeals board to which property owners may appeal the classification of their property under the terms of this Ordinance. An Ordinance amending McCracken County Ordinance No 2023-03 by setting forth a current salary and classification table, to reflect cost of living adjustments and establishing anniversary dates for the purpose of computing step increases for new hires and promotions for certain employees in the McCracken County Clerk's Office.

Summary: The present Ordinance sets forth the current salary and classification table for the McCracken County Clerk's Office by amending ordinance number 2023-03.
