An ordinance amending McCracken County Ordinance 2024-09 by making revisions to the McCracken County Administrative Code pertaining to sick leave provisions.

Summary: The actions effectuated in the present Ordinance operate to amend the existing Ordinance 2024-05 by updating the sick leave policy to allow for partial payout of sick leave and establishing the parameters of the payout.
