E. It is ordered that the following Resolution be adopted:

A Resolution Levying the Tax Rate for the Year 2024 for Taxes to Be Collected for the Benefit of McCracken County, Kentucky

Be it Resolved, the Fiscal Court of McCracken County, Kentucky, for the calendar year beginning January 1, 2024, levy a tax rate of .106 on each \$100.00 of value on real estate and a tax rate of .1574 on each \$100.00 of value on tangible property, located within McCracken County and assessed by said county and by the Kentucky Department of Revenue and that taxes further be levied at a rate of 0.025 on each \$100.00 of value on all bank shares, located within said county, and that taxes further be levied at a rate of 0.00 on each \$100.00 on all unmanufactured tobacco.

Be it further Resolved, the revenue raised by the foregoing levy be used for the maintenance of the county government, care of paupers, the upkeep of the public roads and bridges, and all other general expenses of McCracken County, as required and allowable by law.

F. It is ordered that the following Resolution be adopted:

A Resolution Levying the Tax Rate for the Year 2024 for Taxes To Be Collected for the Benefit of the McCracken County Health Department

Whereas, the McCracken County Board of Health, on behalf of the McCracken County Public Health Department, has requested the McCracken County Fiscal Court to impose by Resolution a special ad valorem public health tax in the amount of 0.03 per \$100.00 of assessed valuation of real estate and tangible property in said county as of January 1, 2024, which is in addition to all other ad valorem taxes; Be it Resolved that this tax hereby be levied.

G. It is ordered that the following Resolution be adopted:

A Resolution Levying the Tax Rate for the Year 2024 for Taxes To Be Collected for the Benefit of the McCracken County Mental Health Center

Whereas, the Western Kentucky Regional Mental Health and Mental Retardation Board, Inc., on behalf of the McCracken County Mental Health Center, has requested the McCracken County Fiscal Court to impose by Resolution a special ad valorem mental health tax in the amount of 0.012 per \$100.00 of assessed valuation of real estate and tangible property in said county as of January 1, 2024, which is in addition to all other ad valorem taxes; Be it Resolved that this tax hereby be levied.

H. It is ordered that the following Resolution be adopted:

A Resolution Levying the Tax Rate for the Year 2024 for Taxes to Be Collected for the Benefit of the College Support District

Be it Resolved, the Fiscal Court of McCracken County, Kentucky, for the calendar year beginning January 1, 2024, pursuant to Kentucky Revised Statutes 165.175, levy a tax rate of 0.014 on each \$100.00 of value on real estate and a tax rate of 0.013 on each \$100.00 of value on tangible property, except all inventory, located within the College Support District, which consists of all property in McCracken County outside the city limits of the City of Paducah, and that taxes further be levied at a rate of 0.025 on each \$100.00 of value on all bank shares located within the College Support District.

COMMONWEALTH OF KENTUCKY MCCRACKEN COUNTY FISCAL COURT ORDINANCE NO. 2024-10

AN ORDINANCE AMENDING MCCRACKEN COUNTY ORDINANCE NO.2024-03 AND 2024-07 BY SETTING FORTH A CURRENT SALARY AND CLASSIFICATION TABLE UPDATED TO REFLECT CURRENT STAFFING REQUIREMENTS IN THE MCCRACKEN COUNTY CLERK'S OFFICE

COMMONWEALTH OF KENTUCKY MCCRACKEN COUNTY FISCAL COURT ORDINANCE NO. 2024 – 11

AN ORDINANCE ESTABLISHING A CODE ENFORCEMENT BOARD IN THE COUNTY AND DESCRIBING CODE ENFORCEMENT PROCEEDINGS.

Summary: The action effectuated in the present Ordinance operates to create a McCracken County Code Enforcement Board that will serve as an enforcement body and avenue of appeal for violations of applicable sections of the McCracken County Code of Ordinances. Further, the present ordinance operates to establish enforcement proceedings for violations of applicable county ordinances. Additionally, the present Ordinance operates to establish a method for the county to enforce liens arising from violation fines, fees, and costs of abatement, and to notify lienholders of the same.

COMMONWEALTH OF KENTUCKY MCCRACKEN COUNTY FISCAL COURT ORDINANCE NO. 2024 – 12

AN ORDINANCE REPEALING THE JUNKED MOTOR VEHICLE ORDINANCE AND REPEALING AND REPLACING THE PROPERTY

MAINTENANCE ORDINANCE WITH AN UPDATED PROPERTY MAINTENANCE CODE THAT DESCRIBES PROPERTY PRACTICES THAT CONSTITUTE A NUISANCE, CODIFIES AND DESCRIBES THE POSITION OF CODE ENFORCEMENT OFFICER, AND ESTABLISHES ABATEMENT AND ENFORCEMENT PROCEDURES.

Summary: The actions effectuated in the present Ordinance operate to repeal the Junked Motor Vehicle Ordinance and repeal and replace the property maintenance code. Further, the updated property maintenance code describes property ownership practices that constitute a nuisance, codifies and describes the position of code enforcement officer, and establishes abatement and enforcement procedures.
