ORDINANCES 91-2 AND 2000-6 IN THEIR ENTIRETY AND
ABOLISHING THE LANDLINE FEE.

Summary: The present ordinance repeals McCracken County Ordinances 91-2 and 2000-6 in their entirety. This action is taken to abolish the landline fee and cease the collection thereof, pursuant to Section V(C) of the Interlocal Agreement for the Provision of Emergency 911 Services entered between McCracken County and the City of Paducah.
