It is ordered that the necessary cash transfers, in the amount of \$390,000.00 be made in order to pay County bills and payroll approved August 25, 2025.

V. COURT ORDERS

- A. It is ordered that the Judge Executive is authorized to sign a resolution relating to ownership and maintenance responsibilities of roads that have been determined by both the Kentucky Department of Transportation and the McCracken County Road Department each party agrees to accept the roads as outlined within the resolution. It is further ordered that the Judge Executive is authorized to sign all documents related to the same.
- B. It is hereby ordered to receive and file sealed bids for Temporary Fencing at the Paducah Sports Park. The sealed bids were unsealed and opened at 2:05 PM on May 23, 2025, in the courthouse. All bids were taken under advisement.
- C. It is hereby ordered that Sportaflex be awarded the Bid Package for the Temporary Fencing at the Paducah Sports Park for \$314,309.31. Sportaflex was selected based on being the low bidder after competitive negotiations. It is further ordered that the Judge Executive be authorized to enter into a contract and sign all necessary documents for same; and the Treasurer be authorized to pay invoices.

- F. It is ordered that the following Resolution be adopted:

A Resolution Levying the Tax Rate for the Year 2025 for Taxes to Be Collected for the Benefit of McCracken County, Kentucky

Be it Resolved, the Fiscal Court of McCracken County, Kentucky, for the calendar year beginning January 1, 2025, levy a tax rate of .107 on each \$100.00 of value on real estate and a tax rate of .171 on each \$100.00 of value on tangible property, located within McCracken County and assessed by said county and by the Kentucky Department of Revenue and that taxes further be levied at a rate of 0.025 on each \$100.00 of value on all bank shares, located within said county, and that taxes further be levied at a rate of 0.00 on each \$100.00 on all unmanufactured tobacco. The rates stated reflect the compensation rate needed to maintain the revenue balance at the level of the prior year.

Be it further Resolved, the revenue raised by the foregoing levy be used for the maintenance of the county government, care of paupers, the upkeep of the public roads and bridges, and all other general expenses of McCracken County, as required and allowable by law.

- G. It is ordered that the following Resolution be adopted:

A Resolution Levying the Tax Rate for the Year 2025 for Taxes To Be Collected for the Benefit of the McCracken County Health Department

Whereas, the McCracken County Board of Health, on behalf of the McCracken County Public Health Department, has requested the McCracken County Fiscal Court to impose by Resolution a special ad

valorem public health tax in the amount of 0.03 per \$100.00 of assessed valuation of real estate and tangible property in said county as of January 1, 2025, which is in addition to all other ad valorem taxes; Be it Resolved that this tax hereby be levied.

H. It is ordered that the following Resolution be adopted:

A Resolution Levying the Tax Rate for the Year 2025 for Taxes To Be Collected for the Benefit of the McCracken County Mental Health Center

Whereas, the Western Kentucky Regional Mental Health and Mental Retardation Board, Inc., on behalf of the McCracken County Mental Health Center, has requested the McCracken County Fiscal Court to impose by Resolution a special ad valorem mental health tax in the amount of 0.012 per \$100.00 of assessed valuation of real estate and tangible property in said county as of January 1, 2025, which is in addition to all other ad valorem taxes; Be it Resolved that this tax hereby be levied.

I. It is ordered that the following Resolution be adopted:

A Resolution Levying the Tax Rate for the Year 2025 for Taxes to Be Collected for the Benefit of the College Support District

Be it Resolved, the Fiscal Court of McCracken County, Kentucky, for the calendar year beginning January 1, 2025, pursuant to Kentucky Revised Statutes 165.175, levy a tax rate of 0.014 on each \$100.00 of value on real estate and a tax rate of 0.013 on each \$100.00 of value on tangible property, except all inventory, located within the College Support District, which consists of all property in McCracken County outside the city limits of the City of Paducah, and that taxes further be levied at a rate of 0.025 on each \$100.00 of value on all bank shares located within the College Support District.
