It is ordered to approve the Consent Agenda for October 13, 2025, McCracken County Fiscal Court.

II. BUDGET TRANSFERS

It is ordered that the necessary cash transfers, in the amount of \$575,000.00 be made in order to pay County bills and payroll approved October 13, 2025.

It is ordered to approve the Voucher Claims Register from September 19, 2025, to October 13, 2025, to show County bills in the amount of \$857,740.07 were paid.

V. BOARD APPOINTMENTS

- A. It is ordered that Alan Clay Robinson is appointed to the McCracken County Planning Commission to fill the vacancy created by the resignation of Wayne Elliott. His term will expire September 30, 2026.

VI. COURT ORDERS

- A. It is hereby ordered that Bobcat of Paducah be awarded the quote for one Bobcat Compact Track Loader (T64 T4) at the Paducah Sports Park for \$64,500.00. Bobcat of Paducah was selected based on a Cooperative Purchasing agreement from Sourcewell Contract #1020223. It is further ordered that the Judge Executive be authorized to enter into a contract and sign all necessary documents for the same; and the Treasurer be authorized to pay invoices.

- B. It is ordered that the Judge Executive enter into a Grant Agreement with Lifeline Recovery Center for the amount of \$150,000.00. This agreement establishes recordkeeping, reporting, and how the funds can be used. It is further ordered that the Treasurer is authorized to pay the approved amount.

- C. It is ordered to approve the September 2025 Transient Room Tax in the amount of \$386,858.44 be disbursed as follows:

- D. It is ordered to approve Change Order No. 1 with Midwest Netting Solutions, LLC in the amount of (\$66,684.67) for the design changes from 8 double to 2 quad batting cages. This amends the total bid package from \$188,390.00 to \$121,705.33. It is further ordered that the Judge Executive and Treasurer are authorized to issue purchase orders and pay invoices for the same.
- E. It is ordered to pay Emergency Services Marketing Corp, Inc. \$899.00 for the annual renewal of the I Am Responding paging system subscription for Emergency Management.

An Ordinance amending McCracken County Ordinance No. 2025-08 by making revisions to the proposed Fiscal Year 2025-2026 Operating Budget by modifications in receipts from Sheriff Insurance Proceeds, Sheriff Miscellaneous and DOJ Drug Forfeiture in strict compliance with the mandates of Kentucky Revised Statutes Chapter 68.

Summary: The present Ordinance makes revisions to Ordinance 2025-08, McCracken County Proposed Fiscal Year 2025-2026 Operating Budget, pertaining to a modification in receipts from Sheriff Insurance Proceeds, Sheriff Miscellaneous and DOJ Drug Forfeiture.
