## New 3500 Crew Cab Chassis 4x4 with 9ft Dump Bed

The McCracken County Fiscal Court will be accepting <u>sealed bids</u> until 10:00 a.m. on Wednesday November 5, 2025, in the offices of the McCracken County Judge Executive at the McCracken County Courthouse, 300 Clarence Gaines Street, Paducah, KY 42003 for the purchase of a New 3500 Crew Cab Chassis 4x4 with 9ft Dump Bed Truck (or equal) at which time bids will be opened and publicly read in Conference Room A. No bids will be accepted after this time. No faxed or emailed bids will be accepted. All bidders MUST complete and attach the detailed specifications sheet with any exceptions noted (additional pages if needed), and a signed pricing sheet.

**SCOPE:** The intent of these specifications is to describe a New 3500 Crew Cab Chassis 4x4 with 9ft Dump Bed Truck with Tarp and Folding Sides to be used by county government in the Litter Abatement Department. These specifications state the minimum requirements in material and design to perform to the specific vehicle. The bidder shall include literature indicating current design, standard equipment and included options.

**GENERAL INSTRUCTIONS TO BIDDERS:** All equipment furnished shall be new (no dealer demonstrator models). Any exceptions should be noted. All submitted bid pricing shall be good for 60 days. The McCracken County Fiscal Court reserves the right to award bids on the basis of lowest and best bid, to alter bid specifications, waive minor informalities, to reject any and all bids, and to re-advertise for bids.

Vehicles furnished in general compliance with this specification shall be a new 3500 Crew Cab Chassis 4x4 with 9ft Dump Bed with Tarp and Folding Sides, or equal and shall be of good quality as to workmanship and manufacturer's literature as standard equipment shall be factory installed (include fleet packages when part of bid award). All vehicles purchased under this price contract shall be factory equipped with safety equipment and in conformance with the federal motor vehicle safety standards and vehicle emissions regulations applicable at time of delivery. Successful bidder shall minimally supply one (1) operator's manual upon delivery and two (2) key fobs. Vehicles shall be equipped with manufacturer's standard equipment as listed in the manufacturer's literature, including such equipment that comes standard, plus any accessories specified herein which may be optional.

**EXCEPTIONS TO THE SPECIFICATIONS:** Any variation between the requirements of this specification and or specifications made part of the bid invitation must be listed. Attach additional information if needed. Unless the context requires it, or is noted otherwise, specifications should be interpreted as minimums. Failure on the part of the bidder to comply with any and all requirements and conditions of this specification may subject the bid to rejection. If no exceptions or deviations are shown, the bidder will be required to furnish material exactly as specified. The burden of proof for compliance

with this specification will be the responsibility of the vendor. To be considered for award, offers of "equal" products, including "equal" products of the brand name manufacturer, must meet the salient physical, functional, or performance characteristics specified in this solicitation. Bid exceptions must include descriptive literature such as illustrations, drawings, or a clear reference to previously furnished descriptive data or information available to the county; and clearly describe any modifications the offeror plans to make in a product to make it conform to the solicitation requirements. Mark any descriptive material to clearly show the modifications. The McCracken County Fiscal Court will evaluate "equal" products on the basis of information furnished by the offeror. The McCracken County Fiscal Court is not responsible for locating or obtaining any information not identified in the offer.

**FACTORY WARRANTY:** Manufacturer's standard guarantee against defective parts and engineering to apply in accordance with statement of policy. The bidder shall maintain a full-service maintenance facility and fully stocked parts facility capable of full electrical and body repair. Factory-trained, qualified service personnel shall be present at the shop. Bidder shall state location and provide documentation of service facility.

DELIVERY: All vehicles shall be delivered F.O.B. to McCracken County Road Department, Paducah, Kentucky 42003 within the delivery period as designated by the contractual document. Should the vendor be unable to deliver as specified, written notice must be submitted to the McCracken County Judge-Executive's office prior to the termination of the delivery period specified. Said notice shall detail the reason (s) for non-compliance with the delivery commitment and offer a revised delivery date for acceptance by the county. Failure to deliver as specified shall be just cause for the county to cancel the contractual agreement and for disqualification of the vendor as responsible bidder. STATE IN BID THE TIME NEEDED AFTER RECEIPT OF ORDER FOR DELIVERY.
